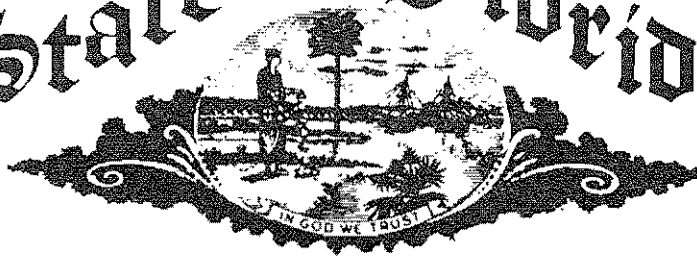



ARTICLES OF INCORPORATION  
OF  
Florida Alliance for Assistive Services and Technology, Inc.

The undersigned, desiring to form a corporation not for profit under the laws of the state of Florida, hereby certifies:

1. The name of the corporation is Florida Alliance for Assistive Services and Technology, Inc.
2. This corporation is organized exclusively for charitable, educational and scientific purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under §501(c)(3) of the Internal Revenue Code (this section or any corresponding section of any future tax code, shall be hereinafter referred to as "§501(c)(3)"). The corporation is organized pursuant to and for purposes consistent with the mandates of §413.407, Florida Statutes (this section, including any successor legislation thereto, shall hereinafter be referred to as "§413.407").
3. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for political office. Notwithstanding anything in these Articles of Incorporation to the contrary, this corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
4. The street address of the corporation's principal office is 2002-A Old St. Augustine Road, Tallahassee, FL.
5. The Board of Directors shall be comprised of all members of the Assistive Technology Advisory Council created under §413.407.

6. The corporation's registered office is 1050-100 South Federal Highway, Delray Beach, FL 33483. The corporation's registered agent is Andrew J. Meyers, Esquire.

7. The incorporator of the corporation is Andrew J. Meyers, Esquire. The incorporator's address is 1050-100 South Federal Highway, Delray Beach, FL 33483.

8. Upon the dissolution of the corporation, its assets shall be distributed to the State of Florida, Department of Labor and Employment Security, Division of Vocational Rehabilitation, unless any particular identifiable asset enters the corporation under conditions requiring that upon dissolution such asset be returned to an identifiable person or entity that is exempt within the meaning of §501(c)(3).
